If you are unable to comply with the ECF filing requirements above, you must submit your written objections on a diskette or CD in Word, WordPerfect or DOS text (ASCII). IF you are unable to file electronically or submit a copy of your filing on diskette or CD, you may file conventionally provided that you submit with your filing an affidavit of your inability to comply.
