**REQUEST FOR PAYMENT OF ADMINISTRATIVE
EXPENSES OF CHAPTER 11**

MARCELLINE MESIDOR, (“Creditor”) hereby requests payment of an as yet unliquidated amount as an administrative expense of the jointly administered Chapter 11 proceeding herein, based upon the following:

1. **Basis for Claim.** The sums requested are damages for discrimination by debtor(s) against creditor based on the creditor’s race (black) and national origin (Haitian) in the work place which resulted and results in lower pay than that to which creditor is entitled and abusive and adverse working conditions overseeing by debtor’s supervisors.

2. **Date Debt was incurred.** The discrimination claim arose after October 27, 2010.

3. **Unsecured Administrative Claims.** This request is filed as an unsecured administrative expense of the Chapter 11 case.

4. **Total Claimed.** The total amount claimed is unliquidated but in excess of \$50,000.

5. **Credit for payment made.** No payments have been made on this debt.

6. **Supporting Documents.** Attached hereto is the affidavit of Marcelline Mesidor dated February 5, 2013, attesting to the discrimination alleged.

MARCELLINE MESIDOR, being duly sworn, deposes and says:

1. I reside at 400 N.W. 141ST Avenue, Apt. 202 Pembroke Pines, FL 33028.
2. I am black woman of Haitian descent. I am presently employed as a cabin attendant by American Eagle/Executive Airlines. While employed by American Eagle/Executive Airlines, I am and have been subjected to insults and name-calling orchestrated by my supervisors all related to my Black and Haitian ancestry. I have been called the voodoo lady and worse and on occasion my supervisors have told my fellow workers that I am retarded specifically because of my Haitian ancestry. I have been

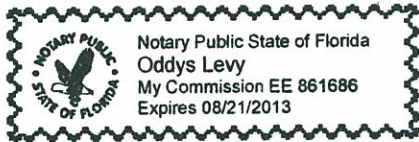
discharged solely as the result of discrimination and after having been recalled, I have been put on probation by my supervisors which is the position I presently occupy. I have flown to and from New York City as an employee during this continuing period of discrimination and I have been advised that I am only one breath away from termination.

3. I know that my current supervisors are harassing me and discriminating against me as a black and Haitian woman, on a daily basis even as I make this affidavit in order to persuade me to quit my employment.
